Finally, the sixth research question asked if teachers trust that Accelerated Reader technology is perceived as effective in helping to improve reading instruction. The results found that teachers' experience, teachers' peer experience, teachers' peer support, and gender were all antecedents that had meaningful statistical relationships with disposition to trust. Gender was found to affect only 1% of the overall variance of disposition to trust when all five variables were examined together; however, findings indicated that females had less disposition to trust than males. Multiple age brackets were found to be insignificant.

Professional researchers in pediatric and child clinical psychology also are challenged to develop new knowledge and skills through continuing education and faculty development programs.
